Leadership Development

- Used Bible passages to answer 3 questions about leaders
 - Acts 6:1-6
 - Timothy 3: 1-10
- What do these passages tell you about selecting leaders for ministry?
- What characteristics of leadership or qualities of leadership are desired in these passages?
- What do these passages tell you about leadership development?
- Thoughts about leaders from the group
 - Exhibit self-control
 - Open to people they are listening to
 - Different levels of leadership
 - Mature disciples (from book)
 - Not new believer; Coming with strong spirit and commitment; Strong faith
 - Not about having answers but willing to engage and grow
- Good things to keep in mind

Spiritual Formation

- Nominations and Leadership Development Team (NLDT) will provide class, possibly this year using Launching Leaders as a resource to grow
- Plan to use book "Launching Leaders" for Spiritual Formation / Leadership Development; what do you think?
- Discussion about pros and cons – good material but what would we be giving up?
- Going to use material as needed in the two topics (Spiritual Formation & Leadership Development) instead of trying to fit a book study into the Leadership Board meetings

Board Accountability
